**RULES:**

Rules of the Contestants approved by the Kewaunee County Fairest of the Fair Committee:

The contest is open to individuals who have been a resident of Kewaunee County and the State of Wisconsin at least one year before entry.

The time, manner, and method of judging will be decided by the Fairest of the Fair committee.

Contestants must be in 6th- 10th grade in school. (Fall 2025-2026)

The decision of the judges is final.

A contestant may be an entrant in only one county or district fair, considered the “home” fair of the contestant. The contestant must reside in the county represented. The only exception: Contestant may reside in an adjoining county, if most fair and/or school activities are in the county where the contestant enters the contest.

Interviews and selection will take place starting at 6 pm on January 9<sup>th</sup>, 2026, at the Fairest Gala, Kewaunee County Fair Grounds, Luxemburg, WI, and concluding around 8 PM.

Further instructions and information will follow.

Parents are responsible for their own financial admittance to the fair and other events that the Jr. Fairest of the Fair program candidates are asked to attend.

Parents must attend a mandatory meeting before the contest starts.

The Kewaunee County Jr. Fairest winner and any members of the Kewaunee County Jr. Fairest Court may not post any pictures or post anything dealing with the Kewaunee County Fairest program on any social media Twitter,

Facebook, etc., without the consent of the Kewaunee Fairest of the Fair Committee or the Kewaunee County Fair Board.

The Jr. Fairest of the Fair and The Jr. Fairest Court may only wear the crown or sash of the Fairest of the Fair program for officially approved functions ONLY.

Junior Kewaunee Fairest of the Fair Duties:

Serve as one of the official hosts or hostess at the 2026 Kewaunee County Fair.

Participate in promotional activities and media events approved by the Kewaunee County Fairest of the Fair Committee. These activities include and are not limited to numerous parades, speaking engagements, and appearances.
